



This is main dashboard that contains summary of your way.

### Oil Section → Barrels





## Oil - Production




After buying barrels you can produce fuel everyday. Your sending barrels affect cost of fuel production.

## Oil → Fuel Sell




After production, you can sell your fuel product with changing every hour fuel price.



You can transfer your fuel to logistics department before selling with your consumption needs. You can transfer your fuel from logistics department for selling.


# Logistics

# Management



On Report Section, You can see your company status with your decisions and how much you pay taxes.


#### Investment


#### **Finance**



On Bank Accounts section, you can manage your money with types of company. Always save your company capital in Main Deposit Account.


